Chapter 1

Purpose

Purpose of this report

This Infrastructure Funding Statement ("IFS") report covers activity regarding Merton's Community Infrastructure Levy ("CIL") and Section 106 agreements ("S106") secured in connection with developments in Merton during the financial year 2023-24 ("the reported year") and future priorities for the investment in infrastructure using CIL, in accordance with the Community Infrastructure Levy Regulations 2010 (as amended) ("the CIL Regulations").

<u>Chapter 2 – Executive Summary</u>: provides a summary of CIL and S106 in Merton and includes some highlights of what has been achieved using both forms of funding during the reported year.

<u>Chapter 3 – Community Infrastructure Levy</u> comprises the statutory reporting information as required by the CIL Regulations including information with respect to income, allocations and expenditure of CIL.

<u>Chapter 4 – Section 106:</u> comprises statutory reporting information on funding secured, received and spent, in addition to providing a summary of non-financial obligations secured under Section 106 agreements for the reported year.

<u>Chapter 5 – The Infrastructure List:</u> provides information on infrastructure projects or project type priorities that the council intends will be, or may be, wholly or partly funded by CIL (other than the CIL income proportion that may be applied to non-infrastructure projects) in future years, as required by the CIL Regulations.

Chapter 2

Executive Summary 2023-24

Community Infrastructure Levy

- 2.1 Since 2014, the council has been collecting its own Community Infrastructure Levy (CIL) funding associated with new development in Merton through the planning process under the CIL Regulations (2010). CIL helps to fund infrastructure in the borough such as local schools, parks, paths, open spaces and healthcare facilities and aims to address the increased demand from new developments.
- 2.2 The council also collects the Mayor of London's CIL which applies to most types of new floorspace. The Mayor's CIL (MCIL) is passed to the Mayor of London to contribute to Crossrail. No information is provided in this report on MCIL as the Mayor reports separately in terms of Mayoral CIL income and expenditure on Crossrail (Mayoral Community Infrastructure Levy).

Income

- 2.3 The council received the following Merton CIL income for the five financial years between 2019-20 and 2023-24:
 - 2019-20 £10,379,063.79
 - 2020-21 £4,120,006.41
 - 2021-22 £6,128,744.26
 - 2022-23 £8,332,927.68
 - 2023-24 £7,037,405.72




Figure 1 – Chart illustrating the CIL income received

Spending the Community Infrastructure Levy

- 2.4 Under the CIL Regulations the council must spend the majority of its CIL receipts on infrastructure to support the development of the borough, it cannot be used to pay off equity or interest on loans and the council cannot borrow funding prudentially on the expectation of CIL receipts.
- 2.5 For unitary authorities and London boroughs like Merton without parishes or neighbourhood plans, the CIL Regulations permit up to 15% of the council's own CIL income to be spent on a wider range of measures that it decides address demands development places on an area.
- 2.6 The Council can expend up to 5% of CIL receipts in any given year on in-year costs for administering CIL.
- 2.7 Funding that is invested more flexibly under the 15% rule as explained above is commonly referred to as *Neighbourhood CIL*, while the remaining funding spent on infrastructure (i.e., excluding funding spent on administering CIL) is referred to as *Strategic CIL*.




Figure 2 – Diagram showing CIL expenditure categories

- 2.8 As illustrated in Figure 2 below, the council's Neighbourhood CIL is comprised of the "Civic Pride Fund – Investing in Neighbourhoods" and the "Ward Allocation Scheme". The council's Climate Action Fund is funded from a separate budget but is managed alongside the Civic Pride Fund.
- 2.9 The Civic Pride Fund is a strategic priority of the council, focused on the council's overarching priority of rebuilding pride in Merton under the three guiding principles of Nurturing Civic Pride, Building a Sustainable Future and Creating a Borough of Sport.

- 2.10 Following on from the previous Ward Allocation Scheme, which ran from 2019 to 2022, the new Ward Allocation Scheme will run from 2023 to 2026 and comprises the following phases:
 - a. Phase 1: 2023/24 focused engagement with all wards, preparation and submission of bids. Allocations confirmed.
 - b. Phase 2: 2024/25 start of spending.
 - c. Phase 3: 2025/26 continued delivery and reporting.
- 2.11 The Council follows bidding, application and governance processes for allocating both Neighbourhood and Strategic CIL. More information can be found on the following webpages:

S106 contributions and agreements

- 2.12 As part of the planning process, the council and owners of a property in relation to which planning permission has been applied for may enter into a legal agreement referred to as a "Section 106 Agreement" or "Planning Obligation". This agreement will set out the terms binding on the owners or developer to provide, facilitate or fund the provision of infrastructure, services or other measures that may be needed for the development to be acceptable in planning terms. The agreement may relate to measures on or off-site and may restrict development for example pending the satisfactory performance of measures or development coordination.

S106 Income and obligations

- 2.14 Income that the Council receives under S106 agreements in any particular year will vary greatly depending on progress of large development schemes for which financial planning obligations are secured. For example, the AFC Wimbledon Stadium development commenced in the 2017-18 financial year which triggered payment of many high value contributions during that year totalling £2.1m. This is almost double the total S106 income from all development during the following financial years 2018-19 and 2019-20 (£1.2m) combined.
- 2.15 Far and away, the most commonly occurring planning obligation is non-financial in the form of restrictions for on-street car parking permits for new residents. These are applied to most new developments comprising additional dwellings in a Merton controlled parking zone (<u>CPZ</u>).
- 2.16 Major developments typically include other in-kind non-financial obligations including highways measures, travel planning, car club membership and the provision of on-site affordable housing, with the S106 agreement stipulating requirements to construct dwellings to be transferred to Registered Providers of social housing to be let or sold to persons unable to afford to rent or buy on the open housing market. In some instances where on-site provision isn't possible, the legal agreement secures a financial payment to the council for the provision of off-site affordable housing. Developers that aren't able to secure sufficient carbon reductions from Part L Building Regulation compliant levels onsite may also be liable to pay a financial contribution for the council to spend on carbon reduction offsetting purposes in the borough.

Spending S106

- 2.17 Terms for spending S106 funding are stipulated in the S106 agreements under which it was paid, usually on specific projects or types of projects that are directly related to the associated development.
- 2.18 Projects will be of the type and in locations that would best address the demand of development that warranted the contribution to be secured. For example, the developers of the residential phases of the AFC Wimbledon Stadium development paid funding for improvements to the nearest open space equipped with play area provision in Garratt Park, Earlsfield, with the funding paid over to London Borough of Wandsworth in 2020-21 under a side agreement to spend in future years. Under the side agreement Wandsworth has committed to provide annual reporting of expenditure of the contribution on Garratt Park, which will be used to inform Merton's annual IFS(s). Further details are provided in Chapter 4.
- 2.19 Development in Merton's neighbourhoods have contributed to town centre public realm and placemaking projects in those neighbourhoods, and in some instances the S106 contributions are used alongside Strategic and/or Neighbourhood CIL funding to ensure that the council's priorities developed on behalf of its communities for investment are fully funded and deliverable.

Highlights for 2023-24

Merton Saints BMX Club

Funded by NCIL.

Improvements and upgrades to the BMX site, including a new Olympic-standard Prostart Gate (the only one in London), a re-built start hill and upgraded LED lighting.

A volunteer-led initiative by local residents and businesses to encourage street and front garden planting with pollinator friendly plants, implemented through community planting days.

Community Infrastructure Levy Matters

Community Infrastructure Levy Regulations (2019 Amendment) Regulation 121A Schedule 2 Section 1

Summary

- 3.1 The information below relates to the Reporting Year (1st April 2023 to 31st March 2024).
- 3.2 This section relates only to Merton CIL and does not include MCIL collected by Merton Council on behalf of the Mayor of London.

Merton CIL collection

- 3.3 The total value of CIL demand notices issued in the reported year is £6,317,795.75. This value is of demand notices issued within the reported year that have not been suspended or superseded by new demand notices outside of the reported year.
- 3.4 Of this total value, the amount from Liability Notices (liable floorspace after any relief that has been granted) is £5,896,611.87. The total value from surcharges imposed due to breaches of the Community Infrastructure Levy Regulations is £234,348.88. The total value of the late payment interest accrued is £186,835.00.
- 3.5 The total amount of CIL collected within the reported year totals £7,037,405.72

Merton CIL Administration

- 3.11 The amount of CIL collected towards administration expenses is £351,870.75. This was 5% of the total CIL receipts collected (£7,037,405.72) in the reported year.
- 3.12 The amount of CIL spent on administration expenses during the reported year was £299,455.05. This was 4.42% of the total CIL collected within the reported year.

Merton CIL Allocations

3.13 As set out above, Merton Council allocates CIL to projects via its financial processes, which includes the Civic Pride Investing in Neighbourhood Fund and the Ward Allocation Scheme. CIL is usually allocated in one year and spent on projects delivered over successive years. Table 5 sets out the projects that received CIL allocations in the reporting year and provides an update on project progress.

S106 Financial Totals

- 4.1 The total amount of money to be provided under any planning obligations which were entered during the reported year is £1,904,900.68. This figure does not consider indexation (inflation/deflation) that may be applied when the money becomes due.
- 4.2 The total amount of money received from planning obligations during the reported year was £1,744,934.81.
- 4.3 The total amount of money from planning obligations spent by the council during the reported year was £220,126.57. A further amount £25,616.09 was spent by a third party on behalf of the London Borough of Merton, as shown in Table 8 below.

- 4.4 Nil planning obligation money was spent on repaying money borrowed, including any interest.
- 4.5 The amount of planning obligation money spent in respect of administration of planning obligations and monitoring in relation to the delivery of planning obligations during the reported year was £16,702.88.
- 4.6 The total amount of money from planning obligations allocated towards infrastructure during the reported year was £138,299.68. Of this amount £24,998.96 was not spent during the reported year. This funding is allocated to specific matters via each S106 legal agreement and will be delivered in accordance with the provisions of each legal agreement. This may be over many years.

- 4.7 The total amount of money retained at the end of the reported year is £13,776,804.10 which is allocated to specific matters via each S106 legal agreement. Of this amount retained, £555,759.50 has been allocated for long term maintenance.
- 4.8 The total amount of money received prior to the reported year that has not been allocated is £4,436,042.17.

- 4.9 During the reported year the following non-monetary contributions have been agreed under planning obligations:
 - The total number of affordable housing units to be provided as on-site provision agreed under planning obligations is 142 (refer to Table 12).

Strategic CIL bids 2024

There will be no formal capital bidding round in 2024 with demands in approved strategic CIL bids exceeding the amount of Strategic CIL funding held. The overall amount of CIL applied to the capital programme will be updated in quarterly financial monitoring reports taken to future Cabinet meetings and project breakdowns will be reported in future IFSs. The cabinet reports will include tables setting out the detailed capital programme for capital funding through to 2027-28. All papers are published on the relevant Cabinet and Full Council agendas in due course at the following locations on the council's website:

The Council's approach in terms of future allocations of funding to projects that have been approved for Strategic CIL funding is to seek to maximise the use of CIL and other external funding such as Section 106 funding and to minimise borrowings in response to future CIL and other external funding receipts. The financial monitoring reporting and process of updating the council's capital programme set out above will reflect this priority. For new bids that may be submitted in the future, the following priorities have been identified:

- i. Statutory
- ii. Infrastructure projects specifically identified in the Local Plan
- iii. Corporate Priorities
 - a. Nurturing a Civic Pride
 - b. Building a Sustainable Future
 - c. Creating a Borough of Sport
 - d. Digital Strategy

All future bids will be assessed to ensure compliance with Regulation 59 of the Community Infrastructure Levy Regulations 2010 (as amended), including that the funding must be used for infrastructure to support the development of the borough.




Ward Allocation Scheme 2023-26 (WAS)

Current Progress:





- As of the 1stNovember 2024 we have delivered 40 out of 61 (66%) of the WAS projects across all Wards.
- All the available funds for all wards have been allocated to projects.
- Some Ward Councillors have chosen to contribute their WAS funds towards larger Civic Pride: Investing in Neighbourhoods projects which are either now completed or to take place early into 2025 (see updates below page 9).
- Financially we are in a strong position, 7 of the 20 wards have an estimated underspend, any underspend < £1000 will be put back into the CIL pot at the end of phase 2. Any underspend > £1000 will be allocated to bulb planting for the 2025 planting season. There is one Ward that has a potential overspend but there are projects yet to be delivered within this Ward that we can amend to get back below budget.
- Actual underspends/overspends will be calculated by Aug 25 when all allocated projects are complete.

Project Highlights



The first 6 months of Phase 2 has seen the delivery and installation of many of the projects in the ward allocation scheme; including the installation of bins, benches, bird boxes and eco towers across the borough. Table tennis tables have been installed at both Ravensbury, Rock Terrace Park and Wimbledon Park along with a pétanque court. Additionally, improvements to the football goals and surface at Oakleigh way rec have been completed. A measured mile and additional wet play features were installed at Dundonald Rec, and a Canopy has been installed in Wandle Park. The Installation of a pétanque court and additional landscape features at Kenilworth has been complete, and all bulb planting locations allocated in the WAS have been planted across the borough.

2024/2025 Project Updates

Martin Way - Greener, Brighter & Revitalised

- Originally a 2022-23 NCIL bid, planters have now been installed along Martin way in a bid to create a greener brighter and revitalised look along the shopping parade of Martin Way. Works began Sept 24 and are now complete with the final amendments to the perimeter of the planters concluding 26th Oct 24.









- Valley Path (Phase 1) complete.

Cannizaro Park Safety (Valley Path)

 Further drainage works relating to the NCIL bid at Cannizaro Park have commenced (phase 2); the aim of which was to complement and enhance last year's NCIL project "the valley path". This last phase connects the pond to the nearby brook several hundred metres away. Works started in mid/late August and already a trench has been excavated and the old drain run replaced.



The new outflow from the pond to the new connection has been paused as there is a currently a parallel project running via Merton, Friends & the EA to address the pond. Once this project is completed, we will then be looking to do the outflow, this outflow was budgeted for in this phase two specification. Most of the projects budget commitment can be spent with a small retention kept aside to cover this.

Morden Recreational Ground – Access, leisure and health.

- MBM Groundworks Limited were awarded the works through the procurement process, there competitive prices have allowed the extension of the path from the side entrance of the park to green lane.
- MBM have been nothing but professional and efficient in their works seeing the entire planned footpath network and extension complete in under 2 months. Works Complete to foot path and side path 29/10/2024.
- Additional plans are now in place to spend the leftover funds on improving the surface and equipment around the playground and outdoor gym.









Figges Marsh – Make Space Safe for Girls Seating Area

- Designs have been finalised for 'Unity Place a unique space where creativity meets comfort, designed for girls to gather, chill and thrive.'
- This is currently being assessed by the friends' group and we are awaiting their feedback, it has all been very positive thus far, they are now just enquiring with a wider audience.
- This project was a Civic pride investing in neighbourhoods (NCIL) bid from the friends of figges marsh endorsed by Cllr kirby.
- The project is looking to cost somewhere in the region of £85-90k. The budget will be comprised of the agreed NCIL allocation, WAS contributions and the money acquired from the network rail agreement.

Joseph Hood Recreational Ground – Basketball Resurface and outdoor Gym (Now Play zone)

- This NCIL project has become part of the wider borough of sport play zones project. The sports and leisure team have consulted at all the 6 sites and currently gathering a summary report.
- The next stages would be to get the feedback and recommendations for the football foundation and then move into the design and technical stage. New advised build could cost £250K with the NCIL budget needed to contribute 25%.



Strategic CIL 2024-25 (SCIL)

In this financial year key maintenance projects funded through strategic CIL have taken place across the borough including the improvement of drainage at Cottenham Park and sports facilities at sir joseph hood rec, resurfacing of the Moreton green wet pour and creating a bunding at top-dress around the carpark at Haydons road rec. In addition to this the sports facilities were revamped and resurfaced at Armfield crescent. Finally, the flower beds and planters outside the civic centre were revitalised and replanted.


Harris Academy Tree Planting

- This project aim was to plant one hundred trees in the locality of the development (Harris Academy, High Path Wimbledon) to mitigate the loss of on-site trees and to reduce air pollution.
- This project worked in consultation with the ward councillors and Friends groups of Abbey rec and Nelson Gardens to produce a tree planting plan that will most benefit the area.
- Throughout OCT 2024 the trees and hedging have been planted by Barklands across the sites, they will be monitored and watered by the arboriculture team alongside barklands for the next 2 years so that they can become established.
- The cost of this project was £49,096 with a budget of £50,000.










Figure 49-55: Harris Academy Trees.
