The Council of the London Borough of Merton, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a) and all other powers thereunto enabling hereby make the following Order: -

- 1. This Order shall come into operation on * 202* and may be cited as the Merton (Waiting and Loading Restriction) (Amendment No. *) Order 202*.
- Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the provisions of Schedule 1 of the London Borough of Merton (Waiting and Loading Restriction) Order 1977(c) are hereby revoked in so far as its provisions relate to any length of Morden Road specified in Schedule 1 to this Order.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Merton (Waiting and Loading Restriction) Order 1977(b) shall have effect as though:
 - (a) there was substituted for the items numbered 166 and 812 in Schedule 1 to that Order the items similarly numbered and set out in columns 1, 2 and 3 of Schedule 1 to this Order:
 - (b) there were added to Schedule 1 to that Order the items numbered *and * and set out in columns 1, 2 and 3 of the Schedule to this Order;
 - (c) there were added to Schedule 3 to that Order the items set out in columns 1, 2 and 3 of Schedule 2 to this Order.
