



PROPOSED WAITING AND LOADING RESTRICTIONS IN VARIOUS ROADS

THE MERTON (WAITING AND LOADING RESTRICTION) (3E) (AMENDMENT NO. *) ORDER 202* **THE MERTON (WAITING AND LOADING RESTRICTION) (M1 AND M2) (AMENDMENT NO. *) ORDER** **202***

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Merton propose to make the above-mentioned Orders under sections 6 and 124 of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the “Waiting and Loading” Orders would be to further amend the London Borough of Merton (Waiting and Loading Restriction) (Controlled Parking Zone 3E) (No. 2) Traffic Order 2007 and the London Borough of Merton (Waiting and Loading Restriction) (CPZ M1 and M2) Traffic Order 2011 so that:-
 - (a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle for 40 minutes) would be prohibited at any time in the roads or lengths of road described in Schedule 1 to this Notice;
 - (b) waiting by vehicles, including for the purpose of delivering or collecting goods or loading or unloading a vehicle, would be prohibited at any time in the roads or lengths of road described in Schedule 2 to this Notice.
3. A copy of each of the proposed Orders and other documents giving more detailed particulars of the Orders, including plans which indicate the roads or lengths of roads to which the Orders relate, can be inspected Mondays to Fridays during normal office hours at Merton Link, Merton Civic Centre, London Road, Morden. 4. SCHEDULE 1

HATHERLEIGH CLOSE, MORDEN;

both sides, from the cul-de-sac extremity north-eastward for a distance for 22.5 metres, except for the parking places.

SCHEDULE 2

EFFRA ROAD, SW19;

- (a) the north side, from a point 2 metres east of the west facing wall of No. 135 Effra Road westward for a distance of 21 metres;
- (b) the south side, from the common boundary of Nos. 184 and 186 Effra Road westward for a distance of 12.3 metres.
