The Council of the London Borough of Merton, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 45, 46 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(a), as amended by section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985(b) and of all other powers thereunto enabling, hereby make the following Order:-

### **PART I - PRELIMINARY**

# **Citation and commencement**

1. This Order may be cited as the Merton (Parking Places) (Permit Charges) Order 202\* and shall come into force on \* 202\*.

### **Interpretation**

2. In this Order "enactment" means any enactment whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

# **Amendments to Various Orders**

### **SCHEDULE 3**

"high carbon dioxide emission petrol vehicle" means a petrol vehicle which produces carbon dioxide emissions at a rate of 226 gCO2/km (grams of carbon dioxide per kilometre) or higher. This is indicated on a current UK registration certificate issued to a vehicle with a registration date on or after 1 March 2001. Emissions for foreign registered vehicles may be determined from vehicle information on the Vehicle Certification Agency website.

"petrol vehicle" means a vehicle in which the motive power is wholly or partially derived directly or indirectly from an internal combustion engine with spark-ignition designed to run on petrol and includes hybrid vehicles which use petrol as a fuel source, and any vehicle powered using an alternative fuel or source of power specified in column 1 of the table in Appendix A to this Order which is classed as "petrol" in column 2 of the table in Appendix A" to this Order.

    - (ii) one-hundred and five pounds in respect of the first residents' permit which shall be valid for a period of twelve months running from the date on which the residents' permit first becomes valid; or
    - (iii) seventy-seven pounds and fifty pence in respect of the second residents' permit which shall be valid for a period of six months running from the date on which the residents' permit first becomes valid; or
    - (iv) one hundred and fifty-five pounds in respect of the second residents' permit which shall be valid for a period of twelve months running from the date on which the residents' permit first becomes valid; or
    - (v) one-hundred and two pounds and fifty pence in respect of the third residents' permit which shall be valid for a period of six months running from the date on which the residents' permit first becomes valid, with this charge increased in increments of £25 for each additional subsequent residents' permit, including the residents' permit being purchased, and each subsequent resident's permit shall be valid for a period of six months running from the date on which the resident's permit first becomes valid; or
    - (vi) two hundred and five pounds in respect of the third residents' permit which shall be valid for a period of twelve months running from the date on which the residents' permit first becomes valid, with this charge increased in increments of £50 for each additional subsequent residents' permit, including the residents' permit being purchased, and each subsequent resident's permit shall be valid for a period of twelve months running from the date on which the resident's permit first becomes valid;
  - (b) in respect of any vehicle of the class specified in Article 6(1), which is also a diesel vehicle or a high carbon dioxide emission petrol vehicle, other than a motorcycle, the charge specified in paragraph (a) of Article 20(4), shall be increased by:-
    - (i) £75 for a residents' permit valid for a period of six months running from the date on which the residents' permit first becomes valid;
    - (ii) £150 for a residents' permit valid for a period of twelve months running from the date on which the residents' permit first becomes valid;

- (c) in respect of any vehicle of the class specified in Article 6(1), which is also an electric vehicle, other than a motorcycle, the charge specified in paragraph (a) of Article 20(4) shall be £50 in respect of the first residents' permit which shall be valid for a period of one year running from the date on which the residents' permit first becomes valid, ;
- (d) there will an additional charge of £25 for the administration of new resident permits issued and for renewals of permits. This charge is waived when a permit holder applies for a renewal within 4 weeks of the permit expiring.

# **SCHEDULE 5A**

- 31.(4) The charge referred to in Article 31(3) shall be as follows:-
  - (a) subject to paragraph (b) of Article 31(4), in respect of any vehicle of the class specified in Article 4(1), other than a motorcycle, shall be three hundred and eighty-five pounds in respect of a business permit which shall be valid for a period of six months running from the date on which the business permit first becomes valid; and
  - (b) in respect of any vehicle being a diesel vehicle or a high carbon emission petrol vehicle of the class specified in Article 4(1), other than a motorcycle, the charge specified in paragraph (a) of Article 31(4), shall be increased by:-
    - (i) £75 for a business permit valid for a period of six months running from the date on which the business permit first becomes valid.
  - (c) in respect of any vehicle being an electric vehicle of the class specified in Article 4(1), other than a motorcycle, the charge specified in paragraph (a) of Article 31(4) shall be reduced by £40 per annum prorata for a minimum of 6 months:
  - (d) there will be an additional £25 charge for the administration of new business permits issued and for renewal of business permits. This charge is waived when a business permit holder applies for a renewal within 4 weeks of the business permit expiring.

#### **SCHEDULE 5B**

- 32.(4) The charge referred to in Article 32(3) shall be as follows:-
  - (a) subject to paragraph (b) of Article 32(4), in respect of any vehicle of the class specified in Article 5(1), other than a motorcycle, shall be three hundred and eighty-five pounds in respect of a business permit which shall be valid for a period of six months running from the date on which the business permit first becomes valid; and
  - (b) in respect of any vehicle being a diesel vehicle or a high carbon dioxide emission petrol vehicle of the class specified in Article 5(1), other than a motorcycle, the charge specified in paragraph (a) of Article 32(4), shall be increased by:-
    - (i) £75 for a business permit valid for a period of six months running from the date on which the business permit first becomes valid.
  - (c) in respect of any vehicle being an electric vehicle of the class specified in Article 5(1), other than a motorcycle, the charge specified in paragraph (a) of Article 32(4) shall be reduced by £40 per annum pro-rata for a minimum of 6 months;
  - (d) there will be an additional £25 charge for the administration of new business permits issued and for renewal of business permits. This charge is waived when a business permit holder applies for a renewal within 4 weeks of the business permit expiring."

### **SCHEDULE 5**

- 27.(4) The charge referred to in Article 27(3) shall be as follows:-
  - (a) subject to paragraphs (b), (c) and (d) of Article 27(4), in respect of any vehicle of the class specified in Article 6(1), other than a motorcycle, shall be three hundred and eighty-five pounds in respect of a business permit which shall be valid for a period of six months running from the date on which the business permit first becomes valid; and

  - (c) in respect of any vehicle being an electric vehicle of the class specified in Article 6(1), other than a motor-cycle, the charge specified in paragraph (a) of Article 27(4) shall be reduced by £40 per annum pro-rata for a minimum of 6 months;
  - (d) there will be an additional £25 charge for the administration of new business permits issued and for renewal of business permits. This charge is waived when a business permit holder applies for a renewal within 4 weeks of the business permit expiring."

### **SCHEDULE 5D**

"36.(4)The charge referred to in Article 36(3) shall be as follows:-

- (a) subject to paragraphs (b), (c) and (d) of Article 36(4), in respect of any vehicle of the class specified in Article 6(1), other than a motorcycle, shall be three hundred and eighty-five pounds in respect of a business permit which shall be valid for a period of six months running from the date on which the business permit first becomes valid;

# **SCHEDULE 6A**

- (5) A teacher permit shall be valid for one year running from the beginning of the day on which it is validated by a teacher.

# **Section 8 – Carer Permits**

## Application for and issue of carer permits

- 50. (1) A resident, who:-
  - (a) is a Blue Badge Holder;
  - (b) has carers attend the resident or applicant daily;
  - (c) does not reside in a permit free housing unit or permit free development, or if they do there is an applicable exception to the issuing of carers permits within the legal agreement relating to the residential unit in question

may apply to the Council or authorised agent for the issue of a carers permit in respect of a vehicle of the class specified in Article 4(1) and any such application shall be made on a form issued by and obtainable from the Council or authorised agent and shall include the particulars and information required by such form to be supplied.

- (2) The Council or authorised agent may at any time require an applicant for a carer permit to produce to an officer of the Council or a representative of the authorised agent such evidence in respect of an application for a carer permit made to them as they may reasonably call for to verify any particulars or information given to them or in respect of any carer permit issued by them as they may reasonably call for to verify that the carer permit is valid.
- (3) Upon receipt of an application duly made under the foregoing provisions of this Article and upon receipt of the charge specified in paragraph (4) of this Article, the Council or authorised agent, upon being satisfied that the application is on behalf of a carer shall issue to the applicant therefor:
  - (a) a carer permit for the leaving at any time during the permitted hours in a parking space in a parking place referred to in Schedules 2 or 3 of a vehicle of the class specified in Article 4(1); and
  - (b) a protective cover for the display therein of each carer permit, as applicable.
- (4) The charge referred to in paragraph (3) of this Article shall be as follows:-
  - (a) in respect of any vehicle of the class specified in Article 4(1), other than a motor cycle, at the rate £10 for a carer permit valid for the period of one year.
- (5) A carer permit shall be valid for one year running from the date it becomes valid, except where:-
  - (a) the carer permit is specified for a shorter period, as specified or requested on the letter of application for medical reasons; or

(b) the carer permit is specified for a shorter period to match the unexpired time remaining on the applicant's relevant blue badge.

# Surrender, withdrawal and validity of carer permits

- 51. (1) A permit holder may surrender a carer permit to the Council or authorised agent at any time and shall surrender a carer permit to the Council or authorised agent on the occurrence of any one of the events set out in paragraph (3) of this Article or in accordance with the provision of paragraph (5) of this Article.
  - (2) The Council or authorised agent may, by notice in writing served on the carer permit holder by sending the same by the recorded delivery service to the carer permit holder at the address shown by that person on the application for the carer permit or at any other address believed to be that person's place of abode or carer, withdraw a carer permit if it appears to the Council or authorised agent that any of the events set out in paragraph (3)(a), (3)(b) or (3)(d) of this Article has occurred and the carer permit holder shall surrender the carer permit to the Council or authorised agent within 48 hours of the receipt of the afore-mentioned notice.
  - (3) The events referred to in the foregoing provisions of this Article are:-
    - (a) the carer permit holder ceases to require the daily attendance of a carer;
    - (b) the withdrawal of such a carer permit by the Council or authorised agent under the provisions of paragraph (2) of this Article;
    - (c) the vehicle in respect of which such a carer permit was issued being adapted or used in such a manner that it is not a vehicle of the class specified in Article 4(1);
    - (d) the issue of a duplicate carer permit by the Council or authorised agent under the provisions of Article 52;
    - (e) the carer permit ceasing to be valid pursuant to the provisions of paragraph (4) of this Article.
  - (4) Without prejudice to the foregoing provisions of this Article, a carer permit shall cease to be valid at the expiration of the period specified thereon, or on the occurrence of any one of the events set out in paragraph (3)(a), (3)(b), (3)(c) or (3)(d) of this Article, whichever is the earlier.
  - (5) Where a carer permit is issued to any person upon receipt of a cheque and the cheque is subsequently dishonoured, the carer permit shall cease to be of any effect and the Council or authorised agent shall, by notice served on the person to whom such carer permit was issued by sending the same by the recorded delivery service to him or her at the address shown by that person on the application for the carer permit or at any other address believed to be that person's place of abode or place of work, require that person to surrender the carer permit to the Council or authorised agent within 48 hours of the receipt of the afore-mentioned notice.

# Application for and issue of duplicate carer permits

- 52. (1) If a carer permit is mutilated or accidentally defaced or the figures or particulars thereon have become illegible or the colour of the carer permit has become altered by fading or otherwise, the carer permit holder shall either surrender it to the Council or authorised agent or apply to the Council or authorised agent for the issue to them of a duplicate carer permit and the Council or authorised agent, upon receipt of the carer permit, shall issue a duplicate carer permit, so marked, and upon such issue the carer permit shall become invalid.
  - (2) If a carer permit is lost or destroyed, the carer permit holder may apply to the Council or authorised agent for the issue to them of a duplicate carer permit and the Council or authorised agent on being satisfied as to such loss or destruction, shall issue a duplicate carer permit, so marked, and upon such issue the carer permit shall become invalid.
  - (3) The provisions of this Order shall apply to a duplicate carer permit and an application therefor as if it were a carer permit or, as the case may be, an application therefor.

### Restriction on the removal of carer permits

53. Where a vehicle displays a carer permit in accordance with the provisions of Article 5(1), 5(2), or 5(3) no person, other than the driver of the vehicle, shall remove the carer permit unless authorised to do so by the driver of the vehicle:

Provided that nothing in this Article shall apply to a civil enforcement officer or a police constable in uniform or any other person removing the vehicle in pursuance of an arrangement made under regulations in pursuance of powers contained in sections 99, 100 and 101 of the Road Traffic Regulation Act 1984.

#### Form of carer permits

- 54. A carer permit shall be in writing and shall include the following particulars:
  - (a) the period during which, subject to the provisions of Article 51(4), the carer permit shall remain valid;
  - (b) an indication that the permit has been issued by the Council or authorised agent; and
  - (c) an indication of the parking zone within which the carer permit is valid.

## Section 9 – NHS Permits

### **Application for and issue of NHS permits**

- 55. (1) A NHS trust may, on behalf of a resident NHS worker, apply to the Council or authorised agent for the issue of a NHS permit in respect of a vehicle of the class specified in Article 4(1) and any such application shall be made on a form issued by and obtainable from the Council or authorised agent and shall include the particulars and information required by such form to be supplied.
  - (2) The Council or authorised agent may at any time require an applicant for a NHS permit to produce to an officer of the Council or a representative of the authorised agent such evidence in respect of an application for a NHS permit made to them as they may reasonably call for to verify any particulars or information given to them or in respect of any NHS permit issued by them as they may reasonably call for to verify that the NHS permit is valid.
  - (3) Upon receipt of an application duly made under the foregoing provisions of this Article and upon receipt of the charge specified in paragraph (4) of this Article, the Council or authorised agent, upon being satisfied that the application is on behalf of a carer shall issue to the applicant therefor:
    - (a) a NHS permit for the leaving at any time during the permitted hours in a parking space in a parking place referred to in Schedule 2 of a vehicle of the class specified in Article 4(1); and
    - (b) a protective cover for the display therein of each NHS permit, as applicable.
  - (4) The charge referred to in paragraph (3) of this Article shall be, in respect of any vehicle of the class specified in Article 4(1), other than a motor cycle, at the rate £75 for a NHS permit valid for the period of one year.
  - (5) A NHS permit shall be valid for one year running from the date it becomes valid, except where the NHS permit is specified for a shorter period, as specified or requested on the letter of application.

## Surrender, withdrawal and validity of NHS permits

- 56. (1) A permit holder may surrender a NHS permit to the Council or authorised agent at any time and shall surrender a NHS permit to the Council or authorised agent on the occurrence of any one of the events set out in paragraph (3) of this Article or in accordance with the provision of paragraph (5) of this Article.
  - (2) The Council or authorised agent may, by notice in writing served on the NHS permit holder by sending the same by the recorded delivery service to the NHS permit holder at the address shown by that person on the application for the NHS permit or at any other address believed to be that person's place of abode or NHS, withdraw a NHS permit if it appears to the Council or authorised agent that any of the events set out in paragraph (3)(a), (3)(b) or (3)(d) of this Article has occurred and the NHS permit holder shall surrender the NHS permit to the Council or authorised agent within 48 hours of the receipt of the afore-mentioned notice.

- (3) The events referred to in the foregoing provisions of this Article are:-
  - (a) the NHS permit holder ceasing to be a NHS worker;
  - (b) the withdrawal of such a NHS permit by the Council or authorised agent under the provisions of paragraph (2) of this Article;
  - (c) the vehicle in respect of which such a NHS permit was issued being adapted or used in such a manner that it is not a vehicle of the class specified in Article 4(1);
  - (d) the issue of a duplicate NHS permit by the Council or authorised agent under the provisions of Article 58;
  - (e) the NHS permit ceasing to be valid pursuant to the provisions of paragraph (4) of this Article.
- (4) Without prejudice to the foregoing provisions of this Article, a NHS permit shall cease to be valid at the expiration of the period specified thereon, or on the occurrence of any one of the events set out in paragraphs (3)(a), (3)(b), (3)(c) or (3)(d) of this Article, whichever is the earlier.
- (5) Where a NHS permit is issued to any person upon receipt of a cheque and the cheque is subsequently dishonoured, the NHS permit shall cease to be of any effect and the Council or authorised agent shall, by notice served on the person to whom such NHS permit was issued by sending the same by the recorded delivery service to him or her at the address shown by that person on the application for the NHS permit or at any other address believed to be that person's place of abode or place of work, require that person to surrender the NHS permit to the Council or authorised agent within 48 hours of the receipt of the afore-mentioned notice.

## Application for and issue of duplicate NHS permits

- 57. (1) If a NHS permit is mutilated or accidentally defaced or the figures or particulars thereon have become illegible or the colour of the NHS permit has become altered by fading or otherwise, the NHS permit holder shall either surrender it to the Council or authorised agent or apply to the Council or authorised agent for the issue to them of a duplicate NHS permit and the Council or authorised agent, upon receipt of the NHS permit, shall issue a duplicate NHS permit, so marked, and upon such issue the NHS permit shall become invalid.
  - (2) If a NHS permit is lost or destroyed, the NHS permit holder may apply to the Council or authorised agent for the issue to them of a duplicate NHS permit and the Council or authorised agent on being satisfied as to such loss or destruction, shall issue a duplicate NHS permit, so marked, and upon such issue the NHS permit shall become invalid.
  - (3) The provisions of this Order shall apply to a duplicate NHS permit and an application therefor as if it were a NHS permit or, as the case may be, an application therefor.

### Restriction on the removal of NHS permits

58. Where a vehicle displays a NHS permit in accordance with the provisions of Article 5(1) or 5(2), no person, other than the driver of the vehicle, shall remove the NHS permit unless authorised to do so by the driver of the vehicle:

Provided that nothing in this Article shall apply to a civil enforcement officer or a police constable in uniform or any other person removing the vehicle in pursuance of an arrangement made under regulations in pursuance of powers contained in sections 99, 100 and 101 of the Road Traffic Regulation Act 1984.

## Form of NHS permits

- 59. A NHS permit shall be in writing and shall include the following particulars:
  - (a) the period during which, subject to the provisions of Article 56(4), the NHS permit shall remain valid;
  - (b) an indication that the permit has been issued by the Council or authorised agent; and
  - (c) an indication of the parking zone within which the NHS permit is valid.

#### **SCHEDULE 7B**

- (4) The charge referred to in paragraph (3) of this Article shall be as follows:-
  - (a) in respect of any vehicle of the class specified in Article 5(1), other than a motor cycle, at the rate £10 for a carer permit valid for the period of one year.
- (5) A carer permit shall be valid for one year running from the date it becomes valid, except where:-
  - (a) the carer permit is specified for a shorter period, as specified or requested on the letter of application for medical reasons; or
  - (b) the carer permit is specified for a shorter period to match the unexpired time remaining on the applicant's relevant blue badge.

# Surrender, withdrawal and validity of carer permits

    - (b) the withdrawal of such a carer permit by the Council or authorised agent under the provisions of paragraph (2) of this Article;

- (c) the vehicle in respect of which such a carer permit was issued being adapted or used in such a manner that it is not a vehicle of the class specified in Article 5(1);
- (d) the issue of a duplicate carer permit by the Council or authorised agent under the provisions of Article 53;
- (e) the carer permit ceasing to be valid pursuant to the provisions of paragraph (4) of this Article.
- (4) Without prejudice to the foregoing provisions of this Article, a carer permit shall cease to be valid at the expiration of the period specified thereon, or on the occurrence of any one of the events set out in paragraph (3)(a), (3)(b), (3)(c) or (3)(d) of this Article, whichever is the earlier.
- (5) Where a carer permit is issued to any person upon receipt of a cheque and the cheque is subsequently dishonoured, the carer permit shall cease to be of any effect and the Council or authorised agent shall, by notice served on the person to whom such carer permit was issued by sending the same by the recorded delivery service to him or her at the address shown by that person on the application for the carer permit or at any other address believed to be that person's place of abode or place of work, require that person to surrender the carer permit to the Council or authorised agent within 48 hours of the receipt of the afore-mentioned notice.

    - (d) the issue of a duplicate NHS permit by the Council or authorised agent under the provisions of Article 58;

  - (a) a carer permit for the leaving at any time during the permitted hours in a parking space in a permit only or shared use parking place referred to in Schedules, of a vehicle of the class specified in Article 6(1); and
  - (b) a protective cover for the display therein of each carer permit, as applicable.
- (4) The charge referred to in paragraph (3) of this Article shall be as follows:-
  - (a) in respect of any vehicle of the class specified in Article 6(1), other than a motor cycle, at the rate £10 for a carer permit valid for the period of one year.
- (5) A carer permit shall be valid for one year running from the date it becomes valid, except where:-
  - (a) the carer permit is specified for a shorter period, as specified or requested on the letter of application for medical reasons; or
  - (b) the carer permit is specified for a shorter period to match the unexpired time remaining on the applicant's relevant blue badge.

### Surrender, withdrawal and validity of carer permits

  - (3) The provisions of this Order shall apply to a duplicate NHS permit and an application therefor as if it were a NHS permit or, as the case may be, an application therefor.

### Restriction on the removal of NHS permits

59. Where a vehicle displays a NHS permit in accordance with the provisions of Article 5(1) or 5(2), no person, other than the driver of the vehicle, shall remove the NHS permit unless authorised to do so by the driver of the vehicle:

Provided that nothing in this Article shall apply to a civil enforcement officer or a police constable in uniform or any other person removing the vehicle in pursuance of an arrangement made under regulations in pursuance of powers contained in sections 99, 100 and 101 of the Road Traffic Regulation Act 1984.

### Form of NHS permits

- 60. A NHS permit shall be in writing and shall include the following particulars:
  - (a) the period during which, subject to the provisions of Article 57(4), the NHS permit shall remain valid;
  - (b) an indication that the permit has been issued by the Council or authorised agent; and
  - (c) an indication of the parking zone within which the NHS permit is valid.
